Club Lodge Sector Survey Intent.

- Deepen the understanding of the makeup of the Sector.
- Build a relationship and establish an engagement platform with the Sector.
- Gain information that might indicate challenges faced by the sector and areas where support could be of assistance.

Club Lodge Sector Survey Methodology:

- All known Club Lodges on Mt Buller were contacted.
- A standardised survey was administered confidentially via an online survey.
- The Survey consisted of both quantitative and qualitative questions.
- If requested one on one assistance with completing the survey was available.
- Telephone follow up was undertaken with Club Lodges that did not initially respond to the survey.



Response to Survey


87 Entities Contacted

20 Did Not Respond or Non Club Lodges




Sector Snapshot (From Respondents)


Clubs wanting to Increase Non-Member bookings

Clubs undertaking Lodge renovations




